

## **PRECAUTIONS:**

Before starting Ferralet 90, determine type and underlying cause(s) of anemia and obtain hemoglobin, hematocrit, and reticulocyte counts. Repeat laboratory testing periodically during prolonged treatment to determine whether therapy needs to be continued without change or if a dose change is indicated.

Gastrointestinal (GI) side effects are a common problem associated with oral iron therapy. Ferralet<sup>®</sup> 90 with Ferr-Ease<sup>®</sup> was formulated to make iron therapy as gentle and comfortable as possible for your patients.<sup>8</sup>

### **DUAL-IRON FOR COMPLEMENTARY ABSORPTION**

Ferr-Ease<sup>®</sup> dual-iron formulation contains both ferrous gluconate and carbonyl iron<sup>1</sup>:

- FERROUS GLUCONATE (Fe<sup>2+</sup>) enters the body in the ferrous state, ready for quick dissolution and absorption to start restoring your patients' vital iron levels.<sup>5</sup>
- PARTICULATE CARBONYL IRON (Fe<sup>0</sup>) requires conversion from its elemental form to the soluble ionized form (Fe<sup>0</sup> + 2H<sup>+</sup>Cl<sup>-</sup>→Fe<sup>2+</sup>Cl<sub>2</sub> + H<sub>2</sub>). It is naturally regulated by the patients' production of gastric acid for gradual absorption.<sup>2,9</sup> Overall, the bioavailability of carbonyl iron is similar to ferrous salts.<sup>2</sup>

Although the overall incidence of FD&C Yellow No. 5 (tartrazine) sensitivity in the general population is low, it is frequently seen in patients who have aspirin hypersensitivity.

**Folic Acid:** Folic acid in doses above 0.1 mg daily may obscure pernicious anemia in that hematologic remission can occur while neurological manifestations remain progressive. Pernicious anemia should be excluded before using this product since folic acid may mask the symptoms of pernicious anemia.

**Geriatric Use:** Clinical studies on this product have not been performed in sufficient numbers of subjects aged 65 and over to determine whether elderly subjects respond differently from younger subjects. Dose selection for an elderly patient should be administered with caution, usually starting at the low end of the dosing range, reflecting the greater frequency of decreased hepatic, renal, or cardiac function, and of concomitant disease or other drug therapy.

#### DESCRIPTION: Each green film-coated tablet for oral administration contains:

Iron (carbonyl iron, ferrous gluconate)	90	mg
Folic Acid	1	mg
Vitamin B <sub>12</sub> (cyanocobalamin)	12	mcg
Vitamin C (ascorbic acid)	120	mg
Docusate sodium	50	mg
Inactive Ingradiants: Povidana, crossarmallasa sodium, acadia rasin, color added ED&C		

**Inactive Ingredients:** Povidone, croscarmellose sodium, acrylic resin, color added, FD&C Yellow No. 5, magnesium stearate, magnesium silicate, FD&C Blue No. 1, polyethylene glycol, vitamin A palmitate, ethyl vanillin.

**CLINICAL PHARMACOLOGY:** Oral iron is absorbed most efficiently when administered between meals. Iron is critical for normal hemoglobin synthesis to maintain oxygen transport for energy production and proper function of cells. Adequate amounts of iron are necessary for effective erythropoiesis. Iron also serves as a cofactor of several essential enzymes, including cytochromes, which are involved in electron transport. Folic acid is required for nucleoprotein synthesis and the maintenance of normal erythropoiesis. Folic acid is the precursor of tetrahydrofolic acid, which is involved as a cofactor for transformylation reactions in the biosynthesis of purines and thymidylates of nucleic acids. Deficiency of folic acid may account for the defective deoxyribonucleic acid (DNA) synthesis that leads to megaloblast formation and megaloblastic macrocytic anemias. Vitamin B<sub>12</sub> is essential to growth, cell reproduction, hematopoiesis, nucleic acid, and myelin synthesis. Deficiency may result in megaloblastic anemia or pernicious anemia.

**INDICATIONS AND USAGE:** Ferralet<sup>®</sup> 90 is indicated for the treatment of all anemias that are responsive to oral iron therapy. These include: hypochromic anemia associated with pregnancy, chronic and/or acute blood loss, metabolic disease, post-surgical convalescence, and dietary needs.

**CONTRAINDICATIONS:** Hypersensitivity to any of the ingredients. Hemolytic anemia, hemochromatosis, and hemosiderosis are contraindications to iron therapy.

Ensure Hgb, Hct, and reticulocyte counts are determined before starting therapy and periodically thereafter during prolonged treatment. Periodically review therapy to determine if it needs to be continued without change or if a dose change is indicated. This product contains FD&C Yellow No. 5 (tartrazine) which may cause allergic-type reactions (including bronchial asthma) in certain susceptible persons. Although the overall incidence of FD&C Yellow No. 5 (tartrazine) sensitivity in the general population is low, it is frequently seen in patients who also have aspirin hypersensitivity.

**Folic Acid:** Folic acid in doses above 0.1 mg daily may obscure pernicious anemia in that hematologic remission can occur while neurological manifestations remain progressive. **OVERDOSAGE:** Symptoms: abdominal pain, metabolic acidosis, anuria, CNS damage, coma, convulsions, death, dehydration, diffuse vascular congestion, hepatic cirrhosis, hypotension, hypothermia, lethargy, nausea, vomiting, diarrhea, tarry stools, melena, hematemesis, tachycardia, hyperglycemia, drowsiness, pallor, cyanosis, lassitude, seizures, and shock.

**DOSAGE AND ADMINISTRATION:** One tablet daily or as directed by a physician. Do not chew tablet.

**STORAGE:** Store at 20°C to 25°C (68°F to 77°F), excursions permitted between 15°C and 30°C (between 59°F and 86°F). Brief exposure to temperatures up to 40°C (104°F) may be tolerated provided the mean kinetic temperature does not exceed 25°C (77°F); however, such exposure should be minimized.

NOTICE: Contact with moisture can discolor or erode the tablet.

**HOW SUPPLIED:** Ferralet<sup>®</sup> 90 (**NDC** 0178-0089-90) is a green, modified rectangle shaped, filmcoated tablet, debossed with "F6" on one side and blank on the other, and packaged in bottles of 90.
